2. What are cookies and what are they used for?

A cookie is a small text file that is placed on your computer by the server of this website, the server of the web applications that you visit or by third-party servers that may or may not cooperate with this website. They help - on an IT technical level - in navigating between the different parts of a website for the user and are responsible for collecting different categories of data.
